Complete all questions and information blocks using the appropriate area on the application.

Application Instructions

Applicant Information: You must provide your full name, complete address, including zip code and telephone numbers. Any communications from the board office will be mailed to the address listed on your application. You have the option to provide your e-mail address, which will be used in the event that all other attempts to contact you are unsuccessful. Your e-mail address is considered a part of your confidential application and will not be released to anyone. If your name, address and/or telephone number(s) change, you must notify the Supreme Court of Pennsylvania, Office of the Prothonotary (Prothonotary) in writing, within 10 days of each occurrence.
